Call to Order:

The meeting was called to order at 10 am by Dr. Lyn Guy, Superintendent, Monroe County Schools.

Guest Speaker:

Shawn Cook, Coordinator RESA-I ABE & SPOKES program, presented the Regional Council with ABE & GED Updates. The West Virginia Adult Education Association will hold the annual conference October 8-10, 2008 at Pipestem State Park. ABE instructors are required to complete six hours of professional development specific to adult education. This conference provides and excellent opportunity for local instructors to complete this training, and also for ABE Directors and other administrators to network and exchange ideas.

GED changes for 2008-09 according to HB4477 and Policy 2444,4 are as follows:

- Sixteen and seventeen-year-old dropouts must be withdrawn from school only one month in order to qualify for GED testing. Eighteen-year-olds are eligible immediately after withdrawing form school. Prior to this, waiting periods could be up to six months, with additional requirements of promised employment or training.
- Each year over 1,500 dropouts, ages 16, 17 and 18 do not acquire their GED diplomas.
- For NCLB reporting, GED graduates are removed from drop out lists, and reported as completers thereby reducing dropout rates.
- The cost of taking the GED exam is now free for everyone.
- Test applicants must pass an official practice test and participate in an orientation process prior to testing.
- These new procedures will require increased coordination between GED examiners and ABE instructors.

National Board Certification

RESA-I held a three-day NBTC workshop at Pikeview High School in June23-25, 2008. The program facilitators will continue working with these teachers as they complete the certification process for National Board. There are additional openings for this program. RESA-I Financial Audit

RESA-I has received a copy of the FY 07 audit. The State Auditor's Office received an extension for completion of the audit due to the high number of audits completed by their office this year. A copy of the report will be mailed to the Regional Council so that they can have adequate time to review. During the FY 07 year, Bill Grizzell served as Executive Director until December, at which time Keith Butcher was employed. While many new procedures and reporting processes were put in place during that year, they did not apply for the entire year leading to seven findings being issued including an adverse opinion for budgeting and reporting procedures. At the present time, there are no findings or concerns that have not been corrected.

- RESA VIII and RESA V were audited by the Office of Education Performance Audits. More RESAs will be audited during the 2008-2009 school year. Audit standards are based on the RESA requirements as prescribed in legislation.
- At the present time no changes are recommended for the annual evaluation process for RESA Executive Directors and no changes are recommended for the RESA State Board 3233, Establishment and Operation of Regional Education Service Agencies

Proposed Salary Increase for RESA-I Computer Technicians.
